DECA Inc. Announces Availability of 10 Conclave Scholarships

DECA Inc. and MBA Research & Curriculum Center have partnered to offer scholarships for new (three or fewer years as a DECA advisor) DECA advisors who have not previously attended the Conclave and Professional Conference. Eight scholarships are available for local DECA chapter advisors and two scholarships are reserved for DECA state/provincial association advisors.

Each scholarship includes a basic Conclave registration, including up to three pre-conference workshops, plus \$250 toward travel expenses—a total value of \$600. Applications are due March 31, 2009. Scholarship winners will be notified by April 6, 2009.

Scholarships are not available to Conclave and Professional Conference participants who are otherwise underwritten by either DECA or MBA Research & Curriculum Center (e.g., DECA scholarship recipients, speakers, Consortium representatives, etc.).
